CERRITOS COLLEGE DUAL ENROLLMENT APPLICATION

Dual Enrollment Application Information for Students, School Principal/Designee and Parent/Guardian. By signing this Dual Enrollment Application, you acknowledge the following:

- A. This program is designed for K-12 students seeking advanced scholastic courses. Cerritos College defines advanced scholastic as:
 - a. Courses meeting Cerritos College requirements for an Associate in Arts Degree, excluding remedial English and math courses.
 - b. Courses that are transferrable to four-year institution (ex. ENGL 100, MATH 140, etc.)
 - c. Vocational courses below 100 level may be taken (ex. COS 50, WELD 52, etc.).
- B. Students shall receive college credit for the community college courses that they successfully complete.
- C. Students may not enroll in pre-collegiate courses (1-99) or physical education courses. Cerritos College has determined that non-transferable and physical education courses are the types of courses that would not be considered "advanced scholastic"
 - a. Auditing a course is the only other option for a student to take a physical education course. Auditing allows the student to participate but they will not receive college credit. Audit fees are not covered by the Dual Enrollment program.
- D. Students may only enroll in courses not available to the student within their school district.
- E. Students may not enroll in a college course to alleviate a high school deficiency. For instance, students who failed a course in high school may not retake it at Cerritos College.
- F. Dual Enrollment students do not receive priority enrollment status. There are no exceptions.
- G. Students that have previously enrolled and dropped their courses and/or have received substandard grades and/or have not made satisfactory progress will not be allowed to continue in the Dual Enrollment Program.
- H. Content in some courses may not be suitable for minors. Cerritos College reserves the right and has the responsibility to restrict dual enrollment if it is determined that the student does not have the ability to benefit from enrollment or for reasons of health and safety, appropriateness of the course, preparedness of the students or college policy.
- I. Completion of the Self-Report Tool (SRT) is an admissions requirement for all Dual Enrollment students regardless of the college coursework the student wishes to enroll in.
 - a. It is the student's responsibility to meet with complete requests for pre-requisite clearances prior to attempting to enroll in classes.
- J. Students must apply for Dual Enrollment every semester.
- K. Students are subject to the Cerritos College Student Code of Conduct.

Fall/Spring Semester Steps to Getting Started for K-10th grade Dual Enrollment students:

1. **Apply to Cerritos College online at www.cerritos.edu/apply**
 - a. Your Cerritos College student number will be emailed to you within 48 hours.
2. **Complete the Self Report Tool (SRT) on My Cerritos student portal.**
3. **Complete the New Student Orientation. For more information visit the Cerritos College Counseling website.**
4. **Download, read and complete the Dual Enrollment Application.**

Student – Read and sign Section I of the application. Make sure to include the course information. You may request to enroll in up to 4 units for fall and spring semesters.

Principal/Designee – Read the entire application and sign Section II.

Parent/Guardian – Read the entire application and sign Section III.

5. **Contact the Cerritos College faculty member teaching the course you are interested in enrolling for permission to enroll.** If they approve, obtain their signature under Section IV of the Dual Enrollment application.
6. **Submit the completed Dual Enrollment Application with all signatures to dualenrollment@cerritos.edu**
7. **Receive an email notification about the status of your application within three business days.**
8. **Enroll in classes on My Cerritos student portal.**
9. **Pay your fees online on My Cerritos student portal.**

Special Instructions for Dual Enrollment in the Summer:

For the summer session a maximum of 5% of the total number of students enrolled at the school's grade level is allowed. Principals are asked to certify this requirement using the Summer Session Certification Form.

The middle or high school you are attending must also complete the **Summer Session Certification Form** in order for your Dual Enrollment application to be considered complete. Plan ahead and begin collecting signatures and forms in January or February for summer enrollment. Enrollment for summer begins in April.
