### EVERYONE WILL BE REQUIRED TO COMPLETE A BANK AFFIDAVIT FORM

NOTE: ALL Bank statements must be original, in English, in U.S. dollars, and no older than 6 months.

#### Submit one or more of these documents to equal the required funds:

- \* Bank statement for checking, savings and/or other accessible bank account
- \* Certificates of deposit; mutual, stock or bond funds; and/or other accessible funds

#### A sponsor's statement and bank documents are required of all sponsors. The sponsor statement should include the following:

- \* A statement that the sponsor will financially support the student
- \* Student's name
- \* Sponsor's name
- \* Sponsor's signature and date

#### The sponsor must submit one or more of these documents to equal the required funds:

- \* Bank statement for checking, savings or other accessible account
- \* Certificates of deposit; mutual, stock or bond funds; and/or other accessible funds
- \* U.S. sponsor must complete Form I-134

#### The following items will be required:

- \* A statement on Company letterhead verifying that the business will financially support the student. The statement should include the student's name and the responsible official's signature.
- \* A bank letter showing name of sponsor as an account holder for the business
- \* Bank statement or Certificates of deposit; mutual, stock or bond funds; and/or other accessible funds

An official letter of sponsorship signed by the appropriate government official is required
